

2025 HELLO SHARON GIVEAWAY OFFICIAL RULES

NO PURCHASE IS NECESSARY TO ENTER OR WIN

1. DESCRIPTION OF CONTEST: The Sharon & Crescent United Credit Union 2025 Hello Sharon Giveaway is designed to give entrants (“Entrants”) the opportunity to win a prize at random.

2. ELIGIBILITY: This promotion is open members, of the Sharon & Crescent Union Credit who are residents of the 50 United States and the District of Columbia, 18 years of age or older at time of entry. Employees of Sharon & Crescent United Credit Union, its affiliates, subsidiaries, advertising, promotion and Internet agencies (collectively, “Released Parties”) and their immediate family members and/or those living in the same household of each are not eligible to enter or win. All federal, state, and local laws and regulations apply. Void where prohibited by law.

3. HOW TO ENTER: Promotion begins 12:00 a.m. Eastern Standard Time (“EST”) on Wednesday, February 5, 2025, and ends at 11:59 p.m. Eastern Standard Time (“EST”) on Monday, March 31, 2025, (the “Promotion Period”). Entrants must access either account or loan information by calling by phone and accessing their loan or account information using Sharon (Sharon & Crescent Union Credit Union Virtual Assistant). All entries must be received by 11:59 p.m. EST on March 31, 2025. Sponsor’s computer is the official time keeping device for this Giveaway. Alternate Entry Method: Enter by mail. Send a 3”x 5” index card with your first and last name, date of birth, complete mailing address, and phone # to Sharon & Crescent United Credit Union, ATTN: Marketing Dept., 1300 Belmont Street, Brockton, MA 02301. On the index card indicate the giveaway name. Any incomplete entry received will not be entered into the Giveaway. A person may only mail one entry throughout promotion period.

4. WINNER SELECTION: A random drawing will be conducted on or about April 4, 2025, from among all eligible entries received. A random drawing will be conducted by a representative of Sharon & Crescent United Credit Union, whose decisions are final. Odds of winning will depend upon the number of eligible entries received. Winners will be contacted via email. Prize may be awarded to an alternate if potential winner is deemed ineligible or does not follow the instructions within the reply from Sharon & Crescent United Credit Union within 24 hours after the date sent, if time permits. If a

winner entered by the alternate method of entry, that winner will be notified by email using the email address provided.

5. PRIZE: Three (3) winners will receive one of the following prizes \$1,000, \$500, \$250. The prize will be deposited into the winner's Sharon & Crescent United Credit Share Savings Account. The winner of the \$1,000 prize will receive a Form 1099-MISC, Miscellaneous Information. The Form 1099-MISC will show the amount of the award in box 3, Other Income. There is no withholding on this payment.
